Gold on January 9, 2015, regarding an email transmitted from the Attorney Hans to The Honorable David P. Gold on which I was copied concerning procedural and evidentiary trial matters in the above-captioned case. These emails are attached to a Motion for Recusal and Disqualification of Judge dated January 22, 2015.
